The California Valley Miwok Tribe (the "Tribe") is currently in the process of evaluating enrollment applications and inquires for membership to the Tribe. Prior to Chairperson Burley's enrollment in the Tribe, the BIA required her to have a determination made as to her Indian lineage.

In order to facilitate the enrollment process, the Tribe hereby requests that you provide any relevant information regarding the individuals below, including (i) information regarding status as Indians, (ii) information regarding membership or affiliation with another tribe, and (iii) information regarding any relationship, connection, or ancestral history with the Miwok Indians.

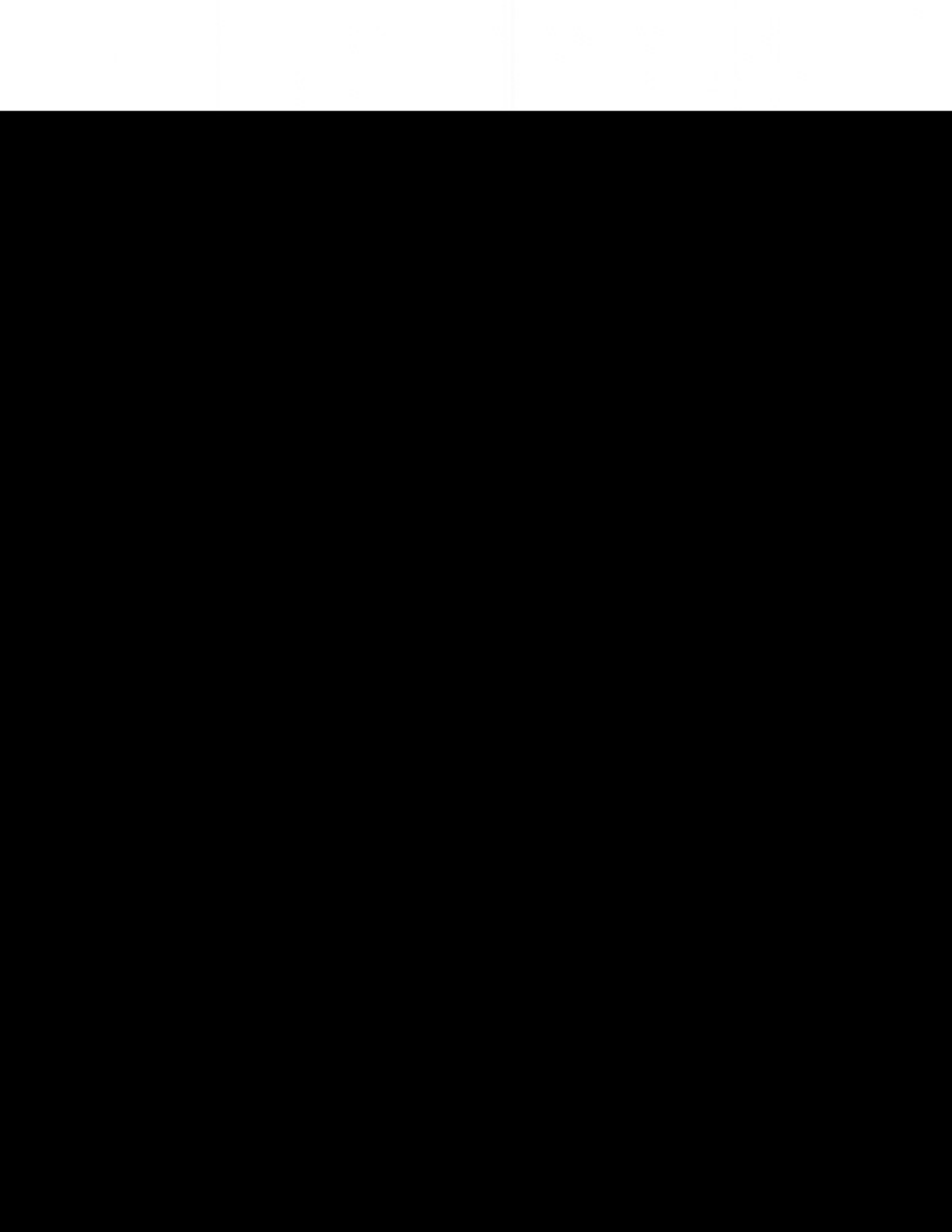
