### PUBLIC NOTICE

**TO: ALL FEDERALLY-RECOGNIZED ENROLLED MEMBERS OF THE  
CALIFORNIA VALLEY MIWOK TRIBE**

**Special Meeting of the General Council  
Of the California Valley Miwok Tribe  
January 7, 2010 at 10:00 am**

**TO BE HELD AT 10601 N. ESCONDIDO PLACE,  
STOCKTON, CALIFORNIA 95212**

In correspondence dated December 22, 2010, the Assistant Secretary of Indian Affairs at the United States Department of Interior rescinded previous letters from the Bureau of Indian Affairs ("BIA"), which challenged the authority, leadership and organizational status of the Tribe. Therefore, the California Valley Miwok Tribe ("Tribe"), acting as an organized entity, wishes to take action to bring the highly contentious period of the Tribe's history to a close. The Assistant Secretary's recent decision also rescinded the BIA letter, dated March 26, 2004, which indicated that Sylvia Burley was "merely a 'person of authority' within the Tribe." Therefore, consistent with previous actions taken by the Tribe, the Tribe presently recognizes Sylvia Burley as its Chairperson.

In accordance with the General Council Resolution #GC-98-01, special meetings of the General Council may be called, upon providing requisite notice (15 days) and elaborating the purpose of the meeting.

Pursuant to General Council Resolution #GC-98-01 and reaffirmed in a recent decision of the Assistant Secretary of Indian Affairs at the United States Department of Interior, dated December 22, 2010, the General Council is the governing body of the Tribe, comprised of four (4) adult federally recognized members: **Sylvia Burley; Yakima Dixie; Anjelica Paulk; and Rashel Reznor.**
