ENROLLMENT COMMITTEE - OFFICIAL NOTICE

Subject: Intent to Disenroll Yakima Kenneth Dixie

Mr. Dixie.

Pursuant to section 08.010 (d) Grounds for Disenrollment. You are charged with being enrolled in another federally recognized Indian Tribe, Band, Community or Group known as Sheep Ranch Rancheria of Mi Wok Indians of California.

- 1.) You are purporting to be the leader of another group, band et., al.
- 2.) You as the leader of your group (along with your representatives) meet and or correspond with governmental officials
- 3.) You enact resolutions to govern your group
- 4.) You enroll members into your group/community
- 5.) Your group employees separate legal counsel rather than the counsel hired to represent the California Valley Miwok Tribe
- 6.) You conduct and or condone separate monthly agenda's, meetings and business dealings from that of the California Valley Miwok Tribe
- 7.) The Tribe is in receipt of a letter dated October 30, 2003 addressed to Aurene Martin, Principal Deputy Assistant Secretary, in this letter you are quoted as declaring, "I, Yakima K. Dixie am the legitimate heir to and the rightful Chief and Chairperson of the Sheep Ranch Rancheria of MiWok Indians of California".
- 8.) May 5, 2003 a formal request to initiate remediation procedure addressed to Ray Fry, Tribal Operations Officer for Tribal Services, you wrote, "I, Yakima K. Dixie, am the hereditary Chief and the rightful Chairperson of the Sheep Ranch Rancheria of MiWok Indians of California, a federally recognized Indian Tribe under the jurisdiction of the BIA".
- 9.) On July 18, 2001 a complaint was filed CIV.S-01 1389 MLS DAD on behalf of Plaintiffs SHEEP RANCH (RANCHERIA) MIWOK INDIAN TRIBE OF CALIFORNIA: YAKIMA DIXIE (CHIEF) MELVIN DIXIE and ROCKY DIXIE.

This has been an ongoing process that the Tribe has restrained itself from taking action on, but with the formation of a separate group with governing documents and given legitimacy by members of the Interior by conducting meetings and representing a separate group/entity it has become clear to the Tribe that your are now in violation of 08.010 section (d) of the California Valley Miwok Tribe.

You have 90 (Ninety) days from the date this letter was mailed, in which to forward evidence to the California Valley Miwok Tribal Enrollment Committee that you have effectively relinquished membership in the other federally recognized Tribe, Band, Community or Group.

If the Enordment Committee fails to receive official notification from the other Tribe of the member's disenrollment within said ninety (90) days, it shall proceed to disenroll the member as an involuntary disenrollment.
