Dear Mr. Rickards:

I received Mr. Dean Shelton's letter of January 3, 2008, sent to me by you under a fax cover sheet. The letter was copied to my client, Ms. Silvia Burley of the California Valley Miwok Tribe ("Miwok Tribe").

I will assume the letter was copied to Ms. Burley erroneously. As you know, the State Bar Rules prohibit a lawyer from contacting, either directly or indirectly, an opposing party being represented by an attorney. I specifically told you in my letter of January 2, 2008, that you were not to contact my client without my permission. I trust it will not happen again. If it does, I will take appropriate action to see that it stops.

Mr. Shelton's letter made no mention of my January 2, 2008 letter. I am assuming that you intend to respond to it, specifically the third paragraph. May I get a response to that paragraph?

Also, Mr. Shelton states in his January 3, 2008 letter, that "the BIA [does not] recognize Ms. [Silvia] Burley as 'an authorized official'". Please provide me with written confirmation to that effect. I did not see that mentioned anywhere in the correspondence you sent me. Are you in possession of a letter or memorandum from the BIA that specifically makes that statement? If so, please send me a copy. If you decline or are unable to do so, I will assume that Mr. Shelton's statement to that effect is false and erroneous.

BE IT FURTHER RESOLVED that until the Tribe's name is formally changed and included into the Federal Register, the Tribe will continue to operate and be known as the California Valley Miwok Tribe aka "Sheep Ranch Rancheria of Me-Wuk Indians of California, and
