In the event of an objection, real party California Gambling Control Commission may file a return to the order to show cause on or before June 18, 2012. Petitioner may file a reply on or before July 9, 2012. Absent a written request on or before July 16, 2012, oral argument will be deemed waived. If a party requests oral argument, the request should be in letter form with proof of service on the other parties. The letter should also identify the focus of the party's argument and the amount of time

		requested, not to exceed 15 minutes.
